

What do we do

In general Governors are either appointed or elected to represent the interests of our foundation trust members and the public. The Council of Governors appoints the Non-Executive members of the Board of Directors (including the Chair) and holds them to account for the performance of the Board.

Our Council of Governors

We have a maximum of 20 Governor seats



public and patient governors are in the majority

Governors' statutory duties and responsibilities

- Appoint and/or remove the chairman and nonexecutive directors
- Set the terms and conditions of remuneration of the chairman and non-executive directors
- Approve the appointment of the chief executive
- Appoint the external auditor
- Receive the annual accounts, auditors report and annual report
- Convene the annual members meeting
- Be consulted on the forward plans (annual plan) of the organisation
- Approve any proposed increases in private patient income of 5% or more in any financial year
- May require one or more of the directors to attend a council of governors meeting to obtain information about the foundation trust's performance of its functions or the directors' performance of their duties (and for deciding whether to propose a vote on the foundation trust's or directors' performance)
- Approve 'significant transactions' (as defined in the foundation trust's constitution)
- Approve an application by the foundation trust to enter into a merger, acquisition, separation or dissolution
- Approve amendments to the foundation trust's constitution
